

Wanneroo Raceway Skidpan - Autotest

1. Entries:

1.1. Open to all MX-5 Club members.

- 1.2. Limited to a maximum of 30 drivers per session.
- 1.3. Entry is open but with preference given to participants competing in the club championship.

2. Event details:

Each round consists of between 6 to 8 challenges run on a sealed surface of approximately 700 to 1350 metres in length. No course will have a straight section of more than 140 metres in length without a significant change of direction. Each course has been designed to test the acceleration, braking, and general manoeuvrability of the vehicle, along with the skill and judgment of the driver. Your worst time from each course will be dropped.

Supplementary Regulations

3. Event type, status and dates:

This Autotest will use the skidpan and possibly part of the race circuit at Wanneroo Raceway and here after referred to as the 'Event'. The Event will run on the scheduled dates as per the published calendar. Only one car will run each course at a time.

4. Authority:

The Event will be held under the Australian Auto-Sport Alliance Pty/Ltd (AASA) National competition rules, these supplementary regulations and any further regulations. This event will be run under AASA Permit No. TBA

5. Organization:

The event will be organised by the MX5 Club of W.A. Inc.

6. Venue:

The event will be conducted on bitumen skidpan at Wanneroo Raceway. Speed should be kept to a walking pace within the pit lane area (approx. 5km/h)

7. Entries: Entrants must e-mail <u>Motorsport@MX5club.com.au</u> with their name and class to register for the event. On the day of the event a fully completed and signed entry & scrutineering form must be submitted.

8. Cost:

Cost per entry: \$70. Whole Series championship competitor's fee has been prepaid.

9. Licences:

As a minimum, all participants must hold a current Australian Auto-Sport Alliance "Club racing licence" or an AASA approved equivalent competition licence.

10. Program:

The event shall comprise between six (6) and eight (8) runs over two different challenges. Diagrams of layouts to be supplied on the day. The running order will be as per ceding rank.

11. Insurance:

The event permit is effective under the Australian Auto-Sport Alliance Pty/Ltd (AASA). A copy of the terms and conditions are available on the AASA website. The event organisers take no responsibility for a participant's comprehensive and life insurance cover whilst at the event. It is your responsibility to check with your insurer, as your personal insurance may not be valid.



12. Conditions:

- 12.1. Cars shall compete with windows either fully up or fully down;
- 12.2. Re-fuelling, repairs of vehicles and changing of wheels are preferred to be done on the cement areas, to protect the bitumen;
- 12.3. A driver whose vehicle has broken down may drive another individual's vehicle; however it must be used for the remainder of the day;
- 12.4. Any vehicle leaking fluids in particular fuel or oil must be removed from any bitumen area immediately.
- 12.5. No competing vehicle may leave the venue during the event without receiving permission from the Clerk of Course. Failure to receive permission will result in exclusion from the event. No warm up or cool down outside of the venue is permitted.

13. Classes:

If competitors are unsure which class they fit into they must get clarification from the motorsport department <u>well before</u> the event.

Class A = Naturally Aspirated MX-5 1.5 to 1.6 litre standard weight, on street tyres.

Class B = Naturally Aspirated MX-5 1.8 to 2 litre standard weight, on street tyres.

Class C = Forced Induction MX-5 (FICE 3.1 cap) standard weight, on street tyres.

OR Naturally Aspirated MX-5 up to 3.1 litre, on R comp tyres(no soft) some weight stripping (level by agreement).

Class D = Any other MX-5, no soft R comp tyres.

Street tyre = tyre with a wear rating of 180 or higher. Forced Induction Capacity Equivalence (FICE) factor = 1.7 Classes A, B and C no aero.

14. Vehicle Requirements:

- 14.1. All vehicles competing shall be clean and tidy, road worthy and road registered, unless by prior approval and at the discretion of the organisers, the vehicle may be inspected;
- 14.2. All loose objects must be removed from the vehicle;
- 14.3. We recommend a 1kg or larger fire extinguisher be fitted within easy reach of the driver.
- 14.4. Tyres must be of a type approved for road use (DOT);
- 14.5. Vehicles must comply with the venue/land owners noise requirements and should not exceed 95dB (A) measured at a point 30 meters from the track edge by approved measuring equipment.
- 14.6. Seatbelts must be fitted to the vehicle and must comply with current Australian Standards.
- 14.7. Any vehicle that has been involved in an incident resulting in damage must be scrutineered again prior to re-entry onto the track

15. Driver Requirements:

- 15.1. Drivers shall wear flame retardant (non-flammable, e.g. cotton) clothing, covering from neck to wrist to ankle (Nylon or synthetic clothing is not permitted) and fully enclosed footwear.
- 15.2. Drivers of cars must wear approved safety helmets as required by AASA. AS1698, BS6658 A/FR, ECE022 04/05, SFI131.1, Snell SA2005 or newer
- 15.3. Drivers must sign supplied indemnity form and agree to all conditions to compete.

16. Event Layout:

Test markers shall be safety cones.



17. Start and Finish:

To start correctly the vehicle must be stationary adjacent to the start marker. The timing starts when the vehicle crosses the start timing beam. For a flying finish the time ends when the beam is broken. For a straddle finish the vehicle must come to a complete stop after breaking the timing beam with the beam remaining in between the centre lines of the front and read wheels (see test instructions)

18. Points:

Each class will get points: - 15 for first, 13 for second, 11 for third etc down to 1 and then 1 point for each competitor after that.

19. Penalties:

"Slowest time" will be based on the fastest time set for each challenge multiplied by 1.333

19.1. A "slowest time" penalty may be added for each of the following:

- 19.1.1. Driving the wrong way;
- 19.1.2. Placing any wheel off the bitumen;
- 19.1.3. Reversing after commencing test;
- 19.1.4. Vehicles running out of order;
- 19.1.5. Not having a straddle finish;
- 19.1.6. Hitting any timing gear.

19.2. A **penalty of 2 seconds** may be added for each of the following:

- 19.2.1. Hitting a cone;
- 19.2.2. Driver unnecessarily delaying event;
- 19.2.3. Leaking fluids on bitumen area;
- 19.2.4. Prolonged wheel spins;
- 19.3. Behaving in an unsportsmanlike/dangerous manner disqualification of driver.

20. Protests:

Any protests are to be directed to the clerk of course only and done so in an orderly and polite manner. All protests shall be assessed by a panel of event Officials. Any abuse of officials or competitors during the event will result in a 6 second time penalty or exclusion from the event.

21. Alcohol and drugs:

Driving under the influence of drugs or alcohol or consumption of alcohol by drivers is forbidden in accordance with NCR and the AASA Anti-Doping Policy. Consumption of alcohol is forbidden until the conclusion of the meeting. The MX5 Club of WA enforces a zero blood alcohol limit and random breath testing may occur at any time on the day. Any Driver found over the zero limits will be asked to leave.

22. Passengers:

Passengers are not permitted.

23. Trophies:

Trophies will be awarded after the conclusion of the club championship.
