I, being the individual described on page 1 of this Participant Registration and Disclaimer Form ("Participant"), and taking part in the event or course specified on page 1 acknowledge, declare and agree:

- to obey the directions of the facilitators, trainers, organiser, or any other persons nominated by RAC to instruct or otherwise control the event or course and to abide by all regulations, rules and procedures communicated to me at all times;
- 2. to (i) drive in a safe and responsible manner at all times; and(ii) abide by applicable road rules; and (iii) to be responsible for the safety of the vehicle(s) I am driving; and (iv) to be responsible for the safety of any passengers in vehicle(s) I am driving;
- 3. motoring activities are inherently dangerous and notwithstanding the exercise of care and skill by RAC, accidents causing death, bodily injury and property damage can and do happen;
- 4. whilst RAC guarantees that the services it provides at the event or course will be provided with due care and skill and will be fit for purpose, to the extent permitted by law (including pursuant to Australian Consumer Law), no other warranties or guarantees are provided to me in respect of the services, whether express or implied;
